PROR projects and storage projects both have reservoirs, the only different between the two beings that PROR projects have a daily regulation while a storage project has a seasonal or annual regulation in our opinion. 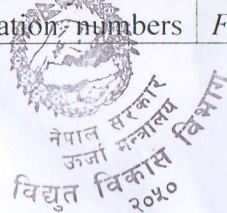
