1. The *Pancheshwar Multipurpose Project* invites sealed bids from eligible bidders for the procurement of one no. of Double Cab 4WD pick-up vehicle.
2. Eligible Nepalese Bidders may obtain further information and inspect the bidding documents at the office of Pancheshwar Multipurpose project, Anamnagar, Kathmandu.
3. Bidding documents may be purchased on or before 30th day from the date of first notice published from the office of Pancheshwar Multipurpose Project, Anamnagar, Kathmandu and the office of Department of Electricity Development, Anam Nagar Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs 1000. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 500. 4. For the purpose of Bidders wishes to submit their bid electronically through website <https://www.gepson.gov.np>, the Bidders may purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bid and submit their electronic bids as specified in the Instructions to Bidders (***Annex -I***). In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the non-refundable fee as specified above in Revenue Head no 14227, Office code No. 27/308/05, Account No. Ka-1-1-244, Nepal Rastra Bank and submit the scanned electronic copy (*.pdf format) of the bank deposit voucher along with the electronic Bid files supported by necessary documents. Also Hard copies of original documents submitted electronically through website <https://www.gepson.gov.np> must be submitted within three (3) days after the time of tender opening for the evaluation.
5. Sealed Bids with necessary supporting documents must be submitted to the above office of Pancheshwar Multipurpose Project, Anamnagar, Kathmandu on or before 12:00 of 31st day from the date of first notice published. Documents received after this deadline shall not be accepted.
6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 31st days from the date of publication at 14:00 at the office of Pancheshwar Multipurpose

Project, Anamnagar, Kathmandu. Bids must be valid for a period of 90 *days* counting from the day of bid opening and must be accompanied by bid security minimum amounting of Rs. 1,00,000 cash deposit in Account No. Sa. A. 131838, Nepal Rastra Bank, Thapathali or in the form of unconditional Bank guarantee from A class Bank in favor of PMP Office, Anamnagar, which shall be *valid for minimum 30 days* beyond the bid validity period.

7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
9. Other terms and conditions will be in accordance with the Procurement Act, 2063, Procurement Regulation, 2064 and the prevailing laws of Government of Nepal.
