Bidding documents may be purchased from the above address of office by eligible bidders on submission of a written application, along with the notarized copy of renewed/valid company/firm registration certificate; VAT certificate; Income Tax Clearance Certificate for FY 072/73 (If bidders wishes to submit Income Tax Submission Certificate for FY 072/73, they must submit Income Tax Clearance Certificate for FY 071/72), self-declaration as per clause 40 - 2 (c) of Public Procurement Regulation, 2064 and payment of a non-refundable fee as mentioned on table below before 30<sup>th</sup> days from first date of publication during office hour. In addition, the bidder must submit certificate of dealership / distributorship / manufacturers.
4. Sealed Bids along with necessary documents must be submitted to office of SKHDMP & SKSDS, house no. 96, Siddhartha Marg, Tin Toliya, Biratnagar-13 on or before 12.00 noon on 2073-6-20. Documents received after this deadline shall not be accepted.
5. Bids shall be opened in the presence of Bidders' representatives who choose to attend bid opening at 14.00 noon on 2073-6-20 at the meeting hall of SKHDMP & SKSDS office. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by the bid security, amounting to amount mentioned below which shall be **valid for minimum 30 days** beyond the bid validity period of the bid. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No. 0601601014070045 (Ko. Le. Ni. Ka. Morang in name of Office Code 10-308-01 with beneficiary name SaptaKoshi High Dam Multipurpose Project and SunKoshi Storage cum Diversion Scheme) in Agricultural Development Bank, Biratnagar and submit the original receipt of the deposited amount of cash along with the Sealed Bid. Absence of the bidder or their authorized representatives, however, shall not obstruct or prevent the opening of the bid in any way.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. The SKHDMP & SKSDS reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
8. Others terms and conditions will be in accordance with Public Procurement Act, 2063, Public Procurement Regulation 2064 and the prevailing laws of Government of Nepal.
