- 2. In order to submit the proposal, the shortlisted proponents may purchase Request for Proposal (RFP) document from the Procurement Unit, DOED during office hours on or before 2082/04/22 BS, 12:00 noon after submitting a bank voucher of RFP fee being deposited into the Department's deposit account (GON Revenue Account No. 1000100200010000, Office Code 308013501, Revenue Title No. 14229 (Prashasanik Sulka), Bank: Rastriya Banijya Bank, Teku Branch)
- 3. Sealed Proposals containing both Technical Proposal and Financial Proposal (sealed individually as well) must be submitted in hardcopy to Department of Electricity Development, Sanogaucharan, Kathmandu no later than 2082/04/22 BS, 12:00 noon. The Technical Proposal will be opened on the same day at 1:00 PM at the Department of Electricity Development.
- 4. Details of Sealing and Marking of Proposals are provided in the Request for Proposal (RFP) Document.
- 5. If the final date of submission falls on holiday, the next working day will be considered the due date, but the time for submission will remain the same as originally stipulated.
- 6. The evaluation of technical proposal will be based on Technical Capacity (45 marks), Financial Capacity (35 marks), Experience (20 marks).
- 7. The proponent whose technical proposal scores at least 60 marks and proposes the highest Upfront Fee will be selected.
- 8. Detailed instructions to proponents and information related to RFP submission process, eligibility criteria, evaluation methods, pass marks and Technical, Financial Proposal formats etc. are provided in the RFP Document.
- Since no EOI proposal was received for EOI No. DOED/BOOT/ 2081/82/EOI-01 (Beni Kaligandaki Hydropower Project, 50.5 MW) and DOED/BOOT/ 2081/82/EOI-03 (Humla Karnali Hydropower Project, 61.02 MW), these procurement processes have been canceled.
- 10. Because of the insufficient number of EOI being shortlisted in EOI No. DOED/BOOT/ 2081/82/EOI-04 (Inkhu Khola Hydropower Project, 21.4 MW), DOED/BOOT/ 2081/82/EOI-05 (Kaligandaki Upper Hydropower Project, 65.0 MW), DOED/BOOT/ 2081/82/EOI-06 (Loti Karnali PRoR Hydropower Project, 49.5 MW), these procurement processes have also been canceled.
